JORDAN CHRISITAN PREP ACADEMIC CONTRACT

Jordan Chirisitan Prep provides students with college & career pathways through their many course offerings. Our expectations for all students enrolled in our school is that they achieve academic success, acquire meaningful and marketable skills, utilize technology as an educational means, and attain post-secondary educational experiences. To meet these expectations, all students must adhere to the following:

Maintain a minimum overall unweighted 2.0 grade-point average in core subjects (i.e., English, Math, Science, and Social Studies) at the end of each semester. If the student does not show adequate academic progress and his or her grade-point average falls below a 2.0 during the first semester, a conference will be held with the student, parent, and teacher and/ or administrator to initiate the probation process and develop a plan of action to improve the student's grades. If the student's grade-point average falls below a 2.0 at the end of the school year, a final conference will be held and the student will be asked to redo a class they might have failed upon the following year.

First Notification (Progress Report)	Probation Warning: This notice informs the student and parents which areas need improving and advice on what support is necessary.
Second Notification (Report Card)	Probation Contract: A parent conference is required at this point. During this conference, strategy for improvement will be discussed. The student may be denied participation in extracurricular activities. Tutoring log/record must be maintained to demonstrate effective attempts to seek grade improvement.
Third Notification	Final Notice: The student will not be eligible to continue any extracurricular activities nor be involved in community service hours. Parents will be notified of failure and school may be subject to

JORDAN CHRISITAN PREP DISCIPLINE / DRESS CODE CONTRACT

Articles of Clothing	Requirements
Shirt	Polo style shirt or school t-shirt. Solid color polo style with collar, long or short sleeved. The appropriate JCP emblem must be worn. School spirit t-shirts may be worn instead of a polo shirt on.
Pants	Solid colors pants or shorts must be worn at the waist. Pants may not sag, Pants may not have patches or holes. Jeans only during the cold season or have paid the Choice Dress code option.

Jackets / Headwear	<p>Solid color sweatshirts, sweaters, or jackets can be worn over school uniforms. If this item has a hoodie, it is not allowed to be worn on the students' head during school.</p> <p>ALL hats, headwear , bandanas, stocking caps, skull caps, scarves or hair wraps will not be allowed on campus or in class. This applies to both male and female students. Having bad hair is not an excuse.</p>
Shoes	<p>Sneakers or other completely closed shoes.</p> <p>No crocs, sandals, open toe or strapless shoes.</p>
